



## CONTEST RULES: EVERYDAY AMERICA

---

**1.- Organizing Company.-** The organizer of this contest is the Spanish legal entity Vacaciones eDreams, S.L.U. (hereinafter, eDreams), with registered office at World Trade Center Norte Pl. 6, Moll de Barcelona, s/n, 08039 Barcelona and Spanish Tax ID Number B-61965778.

**2.- Place and Date.-** The contest will take place on Facebook from the 10th of March, 2014 at 12:00pm, until the 21st of March, 2014 at 16:00pm. The contest is developed for Spain but users from Spain, France, United Kingdom, Germany, Italy and Portugal can participate.

**3.- How to Participate.-** any person who meets the following requirements can participate: (1) be at least 18 years old, (2) reside in a European country and (3) be a fan of one of the eDreams Facebook pages involved in the contest (Spain, France, Portugal, the UK and Germany). All eDreams employees, as well as their partners and closest family members will not be able to participate in this contest. Participation is free. By participating you comply with the terms and conditions that apply to this contest.

### How the contest works:

- The participant can access the Facebook application "Everyday America" on the eDreams profile page of their respective market.

- Once registered, the participant can choose one of six proposed destinations. The chosen city will be the destination they will travel to if selected as one of the travel package (flight and hotel) winners. This destination cannot be altered once the winners have been announced.

- To register successfully, the participant will also need to introduce their personal details (full name and



email address).

- The game consists of inviting as many friends as possible to accumulate additional entries in the prize draw. For every accepted invitation, the participant obtains an additional entry in the prize draw. The invited friends can in turn start their own game.

**4.- Prizes.** - The game consists of 12 prize draws. A prize will be given every day for 12 days.

The following prizes will be awarded in this order:

- The fourth prize is a 100 € discount voucher that can be used for flight bookings on <http://www.edreams.com>. The prize draw will take place between 17:00 and 17:30 pm on March 13, 2014.
- The fifth prize is a 100 € discount voucher that can be used for flight bookings on <http://www.edreams.com>. The prize draw will take place between 17:00 and 17:30 pm on March

- The sixth prize is a 100 € discount voucher that can be used for flight bookings on <http://www.edreams.com>. The prize draw will take place between 17:00 and 17:30 pm on March 15, 2014.
- The seventh prize is a trip for 2 to one of the following destinations: Cancun, Havana, Montevideo, Buenos Aires and São Paulo. The prize draw will take place between 17:00 and 17:30 pm on March 16, 2014.
- The eighth prize is a 100 € discount voucher that can be used for flight bookings on <http://www.edreams.com>. The prize draw will take place between 17:00 and 17:30 pm on March 17, 2014.
- The ninth prize is a trip for 2 to one of the following destinations: Cancun, Havana, Montevideo, Buenos Aires and São Paulo. The prize draw will take place between 17:00 and 17:30 pm on March 18, 2014.
- The tenth prize is a 100 € discount voucher that can be used for flight bookings on <http://www.edreams.com>. The prize draw will take place between 17:00 and 17:30 pm on March 19, 2014.
- The eleventh prize is a trip for 2 to one of the following destinations: Cancun, Havana, Montevideo, Buenos Aires and São Paulo. The prize draw will take place between 17:00 and 17:30 pm on March 20, 2014.
- The twelfth prize is a trip for 2 to one of the following destinations: Cancun, Havana, Montevideo, Buenos Aires and São Paulo. The prize draw will take place between 17:00 and 17:30 pm on March 21, 2014.



Winners and their travel companions cannot win more than once.

Each prize includes:

- Round trip for two people with [Air Europa](#) to the destination chosen at the moment of registration .
- A five night stay in a standard double room at one of the [Melia International Hotels](#) in one of the following destinations: Buenos Aires, São Paulo, Montevideo and Havana. The costs will be assumed by Melia Hotels.
- A five night stay in a standard double room at the TRYP by Wyndham New York City hotel if New York is chosen as the desired travel destination.
- A five night stay in a standard double room at one of the hotels in Cancun. eDreams will select the hotel and assume the costs of accommodation. This only applies if Cancun is chosen as the desired travel destination.
- The period of participation is from the 10th until the 21st of March, 2014. The number of entries accumulated by participants will not be reset after each prize draw .

#### **General conditions for the Prizes**

- The winner should make their reservation (flight & hotel) between the 24th of March of 2014 and the 10th of September of 2014.
- The winner will have to make the reservations at least 45 days before the desired date of



departure, keeping in mind that the last return date is the 24.10.2014..

- The prize/reservations is/are subject to availability of the airline and hotel.
- The prize cannot be exchanged or transferred to someone other than the official winner. If for any reason, the winner renounces the prize, no exchange, refund or compensation will be provided.
- The prize does not include transfers, allowances or other expenses.
- Additional taxes, fees and other expenses related to the prize given out in this contest should be paid by the winner, with exception to the costs assumed by the organizers as disclosed in these rules. Equally, the winner will also bear all costs related to upgrades and extras that do not correspond to the award detailed in these rules.
- The trip prize will be a holiday package (flight and hotel) to the destination selected in the “Everyday America” app. This destination cannot be altered once the winners have been announced.
- There is a limit of 3 trips per destination. In case of picking a winner whose chosen destination has already been selected by 3 previous winners, a new winner will be nominated. If the new winner has also selected the same destination, a third winner will be chosen and so on until a winner is selected with a different pre-selected destination.
- The organizers are not liable for any external factors that might prevent the winner from enjoying his/her trip; to this extent, the organizers will not issue a different prize to the one already provided.
- The organizers are not responsible for the misuse of the prize by the winner.
- In the event that through no fault of the organizing company the prize cannot be delivered as



scheduled, this will be replaced by another of similar features and value.

- The total value of the prize is 11.508 €.

### **Conditions for the flight**

The prize includes two economy class return tickets with **Air Europa** to one of the following destinations: New York, Buenos Aires, São Paulo, Montevideo, Havana and Cancun. Flights will depart from the following countries and cities: Spain (major airports), London (Gatwick), Paris (Orly) Germany (Frankfurt), Portugal (Lisbon), Brussels and Amsterdam. The reservation will be subject to availability. All flights stopover in Madrid.

The winner must use the prize as instructed by email, and should request the tickets before the 10th of September of 2014. He/she should also provide his/her personal details, as well as those of his/her travel companion, allowing a minimum of 45 days before the desired departure date. The latest possible date for the return flight is 24.10.2014.

The winner and his/her travel companion must travel on the same flights. Travel expenses for transportation to the airport, personal insurance, or anything else not specified above, are to be assumed by the winner.

Take Note: The winner must book the flights in accordance with the availability of rooms at the hotel (see hotel conditions).

### **Conditions for the hotel**

The prize includes a five night stay in a standard double room at one of the **Melia International Hotels** in



one of the following destinations: Buenos Aires, São Paulo, Montevideo and Havana. The costs will be assumed by Melia Hotels. If the chosen destination is New York, the prize includes a five night stay in a standard double room at the TRYP by Wyndham New York City hotel. If the chosen destination is Cancun, the prize includes a five night stay in a standard double room at one of the hotels in Cancun. eDreams will select the hotel and assume the costs of accommodation.

Any extra expenses not specified here are assumed by the winner. The reservation of the hotel room is subject to availability.

Take Note: The winner must book the hotel room in accordance with the availability of the airline (see flight conditions).

**Conditions for the discount voucher:**

The discount voucher is valid exclusively for bookings made through Vacaciones eDreams, S.L.U. ([www.edreams.com](http://www.edreams.com)). This can only be used for a sole booking, where any remaining amount cannot be redeemed or used for a second booking. The latest possible date for the booking is the 24/10/2014.
