



## PROMOTIONAL RULES FOR "hAPPy Anniversary"

- 1. **Organizing Company** The organizer of the promotion "Happy Anniversary" (hereinafter , the "Promotion" ) is the Spanish legal entity, Vacaciones eDreams , SL Shareholder Company (hereinafter "eDreams"), with registered office at World Trade Center Norte PI 6, Moll de Barcelona, s/n, 08039 Barcelona, Spain and Spanish Tax ID number: B-61965778.
- 2. **Place and Promotion Date** The contest will take place on the last minute page on Facebook (<a href="https://www.facebook.es/edreams">https://www.facebook.es/edreams</a>) from November 3, 2014, starting at 12:30 p.m., until the December 31, 2014, ending at 23:59 p.m. (hereinafter "Promotional Period"). The draw for choosing the winner, in accordance with the provisions of these rules, will be at the registered office of eDreams, on January 12, 2015.
- 3. **How to Participate** Any person who meets the following requirements can participate: (1) Be at least 18 years of age and (2) Be a resident in Spain (hereinafter, the "Participants"). All eDreams employees, partners, employees and/or their family members, may not participate in the promotion. Participation is free.
- 4. How the Promotion Works- Participants should access the application hosted on Facebook, which will be called "HAPPy Anniversary". Once the application has been accessed, starting November 3, 2014 at 12.30pm until November 13, 2014 at 11:59 p.m., participants will automatically receive a coupon code discount of 5 €, applicable to the purchase of any airline tickets, redeemable through the iPhone App, eDreams (https://itunes.apple.com/es/app/edreams-reserva-los-vuelos/id551367321?mt=8) (in hereinafter the "App") within the same Promotional Period. Each Participant may only use (one) coupon code. The winner will be chosen at random, based off of all of the participants who have redeemed their coupon code and via an automated system for generating random combinations, at the registered office of eDreams, on January 12, 2015.







5. **Prizes**- The winner will receive a prize consisting of the repayment, or refund, of the entire amount of the purchase of airline tickets issued with the promo code obtained in the Facebook application "HAPPy Anniversary".

## **IMPORTANT:**

The refund is only applicable to the total amount of the ticket purchase. Any additional costs incurred including, but not limited to change of ticket date, change of passenger name, change of destination, change of number of bags checked, change of special reserved seats, etc., shall be the passenger's (winner of the promotion's) responsibility.

The organizing company of the promotion will not be liable nor responsible for any external factors, natural incidences, or other circumstances that may prevent the winner from using their tickets. To this extent, the organizing company will not issue a different prize or provide a second refund under any circumstances.

- 6. Causes for Participant Disqualification of the Promotion- Promotion participants will automatically and immediately be disqualified from the Promotion if they violate the rules of "good faith", demonstrate a mendacious, inadequate, misleading or inappropriate conduct, uses disproportionate, fraudulent or improper means, or violates any of the regulations or bases in either way.
- 7. **Income Tax On Individuals** Under Article 43.2 of the Law on Income Tax of Individuals, eDreams will not simulate the income tax of the prize on the winner's account at the time of the award. Notwithstanding the foregoing, in the Letter of Acceptance of the prize consists the same value for the winner to meet his tax obligations, if any.
- 8. **Announcement of the Winner** The winner will be notified via email of their status as the winner of the promotion "HAPPy Anniversary" with exact instructions on how to redeem and enjoy their prize on January 13, 2015. The winner will also be announced on the eDreams page on Facebook on January 13, 2015. If within three (3) calendar days from the draw, the winner cannot be contacted and reaching the winner proves impossible, eDreams will have deemed the winning participant has rejected the award, in which case, eDreams will proceed to the election of a new winner. If , within 3 calendar days from the election of the new (second) winner, it is also not possible to
