

TERMS AND CONDITIONS OF THE PROMOTION: Greekadise

1.- Organizing Company.- The organizer of this promotion is the Spanish legal entity, Vacaciones eDreams , SL – Shareholder Company (hereinafter " eDreams "), with registered office at World Trade Center Norte Pl 6, Moll de Barcelona, s/n, 08039 Barcelona, Spain and Spanish Tax ID number: B-61965778.

2.- Location, date and time of the Promotion.- This promotion will take place in eDreams' Official Facebook page, <https://www.facebook.com/edreams>, during the period between 12:30pm CEST of the 12th of May, 2015 to the 3:00pm CEST of 28th of May, 2015 (hereinafter "Promotional Period"). The promotion has been developed in Spain but users from the United Kingdom, Spain, France, Portugal, Italy and Germany can participate.

3.- How to Enter.- Any person who meets the following requirements can enter this promotion: (1) be at least 18 years of age, (2) reside in an European country and (3) be a fan of one of the eDreams Facebook pages involved in the contest (Spain, United Kingdom, France, Italy, Portugal and Germany). All eDreams employees, partners, employees and/or their family members, may not participate in the promotion. Participation is free.

How the Promotion works:

- The participant will have to access the Facebook application "Greekadise" on the eDreams profile page of their respective market.
- In order to participate correctly, participants will have to register and fill their personal information (name, last names and e-mail) once they access the application.
- Users will be automatically entered in our sweepstakes after registering. However, each participant can invite friends and thus accumulate shares in the draw. For every friend who accepts the invitation, the user gets an extra participation for each of the drawings that will be done. Each of these invited friends may also participate in the sweepstakes.
- Users can only get a maximum of 100 extra chances of winning. In total they can only enter the sweepstakes 100 times.
- Winners will be chosen through a Random system by numbering all participants on an Excel file of the games database.

4.- Prizes.- The game consists of 5 prize draws. We will give away a flight for 2 people to Greece with Aegean Airlines in each draw. The following prizes will be awarded in this order:

- The first prize, which will be awarded to the chosen winner, will take place between 5:00pm and 5:30pm on May 15, 2015.
- The second prize, which will be awarded to the chosen winner, will take place between 5:00pm and 5:30pm on May 19, 2015.
- The third prize, which will be awarded to the chosen winner, will take place between 5:00pm and 5:30pm on May 21, 2015.
- The fourth prize, which will be awarded to the chosen winner, will take place between 5:00pm and 5:30pm on May 26, 2015.
- The fifth prize, which will be awarded to the chosen winner, will take place between 5:00pm and 5:30pm on May 28, 2015.

Each prize consists of round-trip and direct flight tickets, for 2 people in economy class to any of the destinations that Aegean Airlines flies to Greece and that depart from the following airports:

- Spain: Barcelona or Madrid.
- England: Birmingham, London or Manchester.
- France: Paris (Charles de Gaulle), Bordeaux, Marseille, Nantes, Strasbourg, Saint-Gatien-Des-Bois, Metz, Lyon or Toulouse.
- Germany: Berlin, Dusseldorf, Frankfurt, Hamburg, Munich, Stuttgart or Hannover
- Portugal: Lisbon

The chosen flight can't have layovers; it has to be a direct flight with Aegean Airlines from the chosen city of origin.

The total value of the prizes is **2.175€** (corresponding to 10 flight tickets)

General Conditions for the Prizes:

- The winner will have to book the flight at least 45 days before the desired date of departure, keeping in mind that the last return date is October 24, 2015.
- Flight tickets can't be book between July 1 and September 6, 2015. Therefore, the trip must be carried out before or after those dates.
- Dates of the trip are subject to the availability of the airline.
- The plane tickets cannot be exchanged or transferred to anyone other than the official winner and can't be refunded for money or plane tickets of other airlines.
- Any change on the date/passengers names/destination/check-in luggage's/special seats, etc. should be paid by the winner.
- The winner and his/her companion must travel on the same flights. Travel expenses for transportation to the airport, personal insurance, or anything else not specified above, are to be assumed by the winner.
- The organizing company of the promotion will not be liable nor responsible for any external factors, natural incidences, or other circumstances that may prevent the winner from using their tickets. To this extent, the organizing company will not issue a different prize or provide a second refund under any circumstances.
- eDreams is not liable for misuse of the prize by the winner.
- Additional taxes, fees and other expenses related to the prize given out in this contest should be paid by the winner, with exception to the costs assumed by the organizers as disclosed in these rules. Equally, the winner will also bear all costs related to upgrades and extras that do not correspond to the award detailed in these rules.
- In the event that through no fault of the organizing company the prize cannot be delivered as scheduled, this will be replaced by another of similar features and value.

6.- Income tax.- In regard to article 43.2 of the Spanish Law on Personal Income Tax, eDreams will not deposit the amount of the value of the prize in the winners account. However, the total value of the prize will be included in the Letter of Acceptance for the winners' tax obligations, if he/she had any.

7.- Announcement of the Winners.- The winners will be announced in the same app on eDreams' Facebook page on the 15th , 19th , 21st , 26th and 28th of May, 2015 and will also receive an informative email with instructions on how to claim their prize of the GREEKADISE sweepstakes.

The winner has 3 calendar days from the closing date of the contest to accept the prize and to send their contact details to the indicated address, otherwise the prize will be considered rejected and declared void.

In order to formalize the act of delivery of the prize, the Organizer will send a Letter of Acceptance of the Award which will have to be signed by the winner, as proof of reception. The participant authorizes eDreams the right to publish their name on eDreams' websites and on different Facebook pages of eDreams for the following three months after the draw.

8.- Personal Data.- According to the Spanish Personal Data Law (Ley Orgánica 15/1999 of the Protección de Datos de Carácter Personal), we inform the Participants that the personal data provided will be added into a personal data file owned by the organizer. These data will be processed to assure the participation in the contest as well as to process the delivery of the prize, promotion and marketing purposes, which includes sending commercial communications by email. 10.- Disassociation from Facebook.- The participant should know that Facebook does not sponsor, endorse, or manage in any way the promotions that eDreams create on their social networks, nor is Facebook associated with them. By participating in these promotions, the participant is giving eDreams his/hers personal information and not to Facebook. The information provided by the participant will only be used to manage your participation in the promotion. It won't be given to or used by Facebook.

11.- Applicable Law.- This promotion shall be governed by these terms and conditions, which will remain subject to the Spanish Law on gaming and commercial promotions. Any claim related to the sweepstakes ends after 15 calendar days after the final date of the promotion as described in these rules.
