

TERMS AND CONDITIONS OF THE PROMOTION: MEET HELENA

1.- Organizing Company.- The organizer of the promotion "Meet Helena" (hereinafter , the "Promotion") is the Spanish legal entity, Vacaciones eDreams , SL – Shareholder Company (hereinafter " eDreams "), with registered office at World Trade Center Norte PI 6, Moll de Barcelona, s/n, 08039 Barcelona, Spain and Spanish Tax ID number: B-61965778.

2.- Location, date and time of the Promotion.- This promotion will take place on eDreams' Youtube account (<https://www.youtube.com/edreams>) (hereinafter "Youtube") during the period between October 5, 2015 at 12:30pm to October 15, 2015 at 15:00h BST (hereinafter "Promotional Period"). The prize draw will be done in eDreams' headquarters between 14:00 and 14:30 on October 15, 2015.

3.- How to Enter.- The promotion has been developed in Spain but is exclusively reserved for any person who meets the following requirements: (1) be at least 18 years of age, (2) reside in United Kingdom, Germany, Spain, France, or Portugal and (3) be subscriber of our eDreams Youtube channel (hereinafter "Participants"). All eDreams employees, partners, employees and/or their family members, may not participate in the promotion. Participation is free.

4.- How the Promotion works.- Participants should access our video "Meet Helena", in any of our available languages in our Youtube channel. eDreams will publish up to a total of four questions during the campaign period a series of questions in the video descriptions and participants will have to respond to them in the comments section. For every correct response, Participants will obtain an extra chance to win. Participants can only get 1 extra chance per question answered correctly. In total, users will have 4 chances to win. Winners will be chosen through a Random system by numbering all participants on an Excel file of the games database. The prize is limited to one person.

5.- Entry requirements.- Only answers that relate to the theme proposed by the organizing company will be accepted. Obscene answers will not be accepted; neither will those which could harm the moral integrity of users in any way. It's essential to respect the [Youtube community rules](#). All Participants who fail to comply with these requirements will be disqualified.

6.- Prize.- The Prize consists of 3 discount vouchers worth **£72** (100€) each and 1 discount voucher worth **£361** (500€) to be used and claimed on our eDreams websites.

The total value of the prizes is **£578 / 800€ (corresponding to the 4 discount vouchers).**

7.- General Conditions for the Discount Vouchers.- The discount vouchers are valid exclusively for bookings made through Vacaciones eDreams, S.L. and its corresponding websites (<http://www.edreams.es> / <http://www.edreams.pt> / <http://www.edreams.de> / <http://www.edreams.co.uk> / <http://www.edreams.fr>). This can only be used for a sole booking, where any remaining amount cannot be redeemed or used for a second booking. The voucher is only valid for round-trip flight tickets. It's not valid for other products and services nor is it compatible with other offers and discounts. The latest possible date for the booking is the 31st of December, 2015.

The prize can't be exchanged or transferred to anyone other than the official winner and can't be refunded for money or other packages.

8.- Income tax.- In regard to article 43.2 of the Spanish Law on Personal Income Tax, eDreams will not deposit the amount of the value of the prize in the winners account. However, the total value of the prize will be included in the Letter of Acceptance for the winners' tax obligations, if he/she had any.

9.- Announcement of the Winners.- The winners will be announced on our eDreams Youtube channel on October 15, 2015 and will also receive an informative email with instructions on how to claim their prize of the "Meet Helena" sweepstakes. The winner has 10 calendar days from the closing date of the contest to accept the prize and to send their contact details to the indicated address, otherwise the prize will be considered rejected and declared void.

In order to formalize the act of delivery of the prize, the Organizer will send a Letter of Acceptance of the Award which will have to be signed by the winner, as proof of reception.

The winning participants authorize eDreams to publicly post their full names on their websites, blogs and Youtube channel for the next 3 months after the sweepstakes.

10.- Personal Data.- According to the Spanish Personal Data Law (Ley Orgánica 15/1999 of the Protección de Datos de Carácter Personal), we inform the Participants that the personal data provided will be added into a personal data file owned by the organizer. These data will be processed to assure the participation in the contest as well as to process the delivery of the prize, promotion and marketing purposes, which includes sending commercial communications by email. 12.- Disassociation from Youtube.- The participant should know that Youtube does not sponsor, endorse, or manage in any way the promotions that eDreams create on their social networks, nor is Youtube associated with them. By participating in these promotions, the participant is giving eDreams his/hers personal information and not to Youtube. The information provided by the participant will only be used to manage your participation in the promotion. It won't be given to or used by Youtube.

13.- Applicable Law.- This promotion shall be governed by these terms and conditions, which will remain subject to the Spanish Law on gaming and commercial promotions. Any claim related to the sweepstakes will be closed 15 calendar days after the closing date.
