

## TERMS AND CONDITIONS: EDREAMS MITJA MARATÓ

---

**1.- Organizing Company.-** The organizer of the promotion "Pamplona" (hereinafter , the "Promotion" ) is the Spanish legal entity, Vacaciones eDreams , SL – Shareholder Company (hereinafter " eDreams " ), with registered office at World Trade Center Norte PI 6, Moll de Barcelona, s/n, 08039 Barcelona, Spain and Spanish Tax ID number: B-61965778.

**2.- Location, date and time of the Promotion.-** This promotion will take place on Twitter ([https://www.twitter.com/eDreams\\_en](https://www.twitter.com/eDreams_en)), during the period between 12:00pm GMT of December, 14 2015 to 5:00pm GMT of December 17, 2015 ( hereinafter "Promotional Period"). The promotion has been developed in Spain but is exclusively reserved for people that live in England.

**3.- How to Enter.-** Any person who meets the following requirements can participate: (1) be at least 18 years of age, (2) reside in United Kingdom and (3) follow our English Twitter account ([http://twitter.com/eDreams\\_en](http://twitter.com/eDreams_en)). All eDreams employees, partners, employees and/or their family members, may not participate in the promotion. Participation is free.

**4.- How the Promotion works.-** To participate in the sweepstakes, participants must retweet the tweet that eDreams will send out on the first day of the promotion. All participants who have retweeted this tweet will automatically be entered in the draw. Winners will be chosen through a Random system by numbering all participants on an Excel file of the games database. The prize is limited to 1 prize per person/per household.

**5.- Retweet requirements.-** eDreams will disqualify those tweets that include obscene messages which would be prejudicial to the moral integrity of the users or any insults. All retweets must be done during the applicable entry period stated above and must satisfy all other requirements contained or referred to in these Terms & Conditions.

**6.- Prizes.-** The prizes will be given at the end of the promotion on December 18, 2015. They consist of:

**8.- Income tax.-** In regard to article 43.2 of the Spanish Law on Personal Income Tax, eDreams will not deposit the amount of the value of the prize in the winners account. However, the total value of the prize will be included in the Letter of Acceptance for the winners' tax obligations, if he/she had any.
