



TERMS AND CONDITIONS OF THE PROMOTION: "FORGET YOUR RESOLUTIONS"

- **1.- Organizing Company.-** The organizer of this promotion is the Spanish legal entity, Vacaciones eDreams, SL Shareholder Company (hereinafter "eDreams"), with registered office at Calle Bailén, 67-71, , 08009 Barcelona, España y CIF número B61965778.
- 2.- Location, date and time of the Promotion.- This promotion will take place in a set of pages named "Low Cost guides in Europe" hosted in eDreams' Official websites (http://www.edreams.com/low-cost-holidays/ / http://www.edreams.es/escapadas-baratas/ / http://www.edreams.fr/vacances-pas-cher/ / http://www.edreams.de/billig-urlaub-tipps/), during the period between 13:30h GMT of January 18, 2016 to 16:00h GMT February 4, 2016 (hereinafter "Promotional Period"). The promotion has been developed in Spain but users from the United Kingdom, Spain, France, and Germany can participate. The prize draw will be held at eDreams' registered office between 13:00 and 13:30h GMT on February 5, 2016.
- **3.- Eligible participants.-** Any person who meets the following requirements can enter this promotion: (1) be at least 18 years of age, (2) reside in United Kingdom, Spain, France or Germany. All eDreams employees, partners, employees and/or their family members, may not participate in the promotion. Participation is free.
