

TERMS AND CONDITIONS OF THE PROMOTION: "Turin – The Palace of the Alps"

By participating in the competition you declare that you accept these Terms and Conditions unconditionally.

1.- Organizing Company.- The organizer of this promotion is the Spanish legal entity, Vacaciones eDreams , SL – Shareholder Company (hereinafter " eDreams "), with registered office at Calle Bailén, 67-71, 08009 Barcelona, España and CIF number B61965778.

2.- Location, date and time of the Promotion.- This promotion will take place in the official Facebook page of eDreams UK/International (<https://www.facebook.com/edreams>), during the period between 12:30h GMT of May 2, 2016 to 15:00h GMT May 12, 2016 (hereinafter "Promotional Period"). The promotion has been developed in Spain but users from the United Kingdom, can participate. The draw for choosing the winner, in accordance with the provisions of these rules, will be at the registered office of eDreams' registered office between 15:00 and 15:30GMT on May 13, 2016.

3.- Eligible participants.- Any person who meets the following requirements can enter this promotion: (1) be at least 18 years of age, (2) reside in United Kingdom and (3) be a fan of one of the eDreams Facebook page. All eDreams employees, partners, employees and/or their family members, may not participate in the promotion. Participation is free. In order to enter the Facebook sweepstake, participants must become Facebook fans of eDreams.

4.- How to Enter.- Participants should access the application hosted on Facebook, which will be called "Turin – The Palace of the Alps". The application will be accessible, from May 2, 2016 at 12:30h, until May 12, 2016, ending at 15:00h GMT. Once they've registered their personal information (name, surname and email), participants will have to answer correctly to 5 questions related to Turin. Once they've answered the questions correctly, they will automatically be entered in the draw to win the prize. By sharing the application via Facebook, Twitter or Google Plus, the participants will gain an extra entry into the draw. Participants can only gain an extra entry for each of the shared social networks. In total it's possible to gain up to 4 entries in the draw.

5.- Prizes.- The winner will receive a prize with a total value of ONE-HUNDRED EIGHTY-NINE EUROS (189€), which consists of two (2) tickets round trip to Turin departing from London Luton Airport, in Economy Class, with BlueAir.

General Conditions for the Prizes:

- The flight should be round trip to Turin, in Economy Class, departing from London Luton Airport, with the airline BlueAir.
- The flights must take place between May 12, 2016 and October 28, 2016.
- The winner will have to book the flight tickets with a minimum of 30 calendar days prior to the departure date. The last day to request the issuing of the tickets is 30 of June. The winner must follow the instructions received by email, stating his details and those of his companion.
- Travel dates are subject to the availability of the airline, whose choice will be decided by eDreams.
- The tickets are personal and not transferable, and may not be transferred to other people or redeemed for cash neither for tickets of other airlines or for any other product.
- Any additional costs resulting from a change of date, passenger name, destination, number of bags to check, special reserved seat, will be paid by the winner.
- Any other expenses not expressly included in these rules shall be paid by the winner.
- Serving as an example and not limitation, the prize does not include: visas, meals, transfers and trips between home travelers and the selected airport, travel insurance or personal or any other ancillary products or services or unspecified.
- The confirmed winner must comply with and is responsible for attending to and is liable for any costs associated with any travel insurance, inoculation and health regulations, and visa requirements required to visit the destination named in the prize for all members of their party.
- The winner will choose his companion. Both must travel at the same time on the same flights, dates and times. At least one of the passengers must be of legal age.

6.- Income tax.- In regard to article 43.2 of the Spanish Law on Personal Income Tax, eDreams will not deposit the amount of the value of the prize in the winners account. However, the total value of the prize will be included in the Letter of Acceptance for the winners' tax obligations, if he/she had any.

7.- Announcement of the Winners.- The winners will be announced in the Facebook page of eDreams UK on May 13, 2016, and will also receive an informative email with instructions on how to claim the prize of the draw "Turin – Palace of the Alps".
