## TERMS AND CONDITIONS OF THE PROMOTION: "AUSTRALIA"

By participating in the competition you declare that you accept these Terms and Conditions unconditionally.

- **1.- Organizing Company.-** The organizer of this promotion is the Spanish legal entity, Vacaciones eDreams , SL Shareholder Company (hereinafter "eDreams"), with registered office at Calle Bailén, 67-71, 08009 Barcelona, España and CIF number B61965778.
- **2.- Location, date and time of the Promotion.-** This promotion will take place in the official Facebook pages of eDreams UK/International (<a href="https://www.facebook.com/edreams">https://www.facebook.com/edreams</a>. eDreams Spain (<a href="https://www.facebook.com/edreams.fr">https://www.facebook.com/edreams.fr</a>) and eDreams Germany (<a href="https://www.facebook.com/edreams.de">https://www.facebook.com/edreams.fr</a>) during the period between 12:30h GMT of May 18, 2016 to 16:00h GMT May 31, 2016 (hereinafter "Promotional Period"). The promotion has been developed in Spain but users from Spain, the United Kingdom, Germany, and France can participate. The draw for choosing the winner, in accordance with the provisions of these rules, will take place at the registered office of eDreams', on the June 1, between 15:00h and 15:30h GMT.
- **3.- Eligible participants.-** Any person who meets the following requirements can enter this promotion: (1) be at least 18 years of age, (2) reside in Spain, Germany, France or the United Kingdom and (3) be a fan of one of the four eDreams Facebook page. All eDreams employees, partners, employees and/or their family members, may not participate in the promotion. Participation is free. In order to enter the Facebook sweepstake, participants must become Facebook fans of eDreams.
- **4.- How to Enter**.- Participants should access the application hosted on Facebook, which will be called "Australia". The application will be accessible, from May 18, 2016 at 12:30h, until May 31, 2016, ending at 16:00h GMT. Once they've answered them they will automatically be entered in the sweepstake to win the prize. By sharing the application via facebook, twitter or google+, the participants will gain an extra entry to the draw. Only one extra participation for each of the social networks shared. **5.- Prizes.-** The Prize includes 4 round-trip flight tickets for 2 persons, to Adelaide or Sydney from Spain (Barcelona, Madrid) France (Paris) U.K. (London-Heathrow, Manchester, Birmingham, Edinburgh), Germany (Frankfurt, Berlin, Munich) Airports with Qatar Airways. The Prize is valid for one (1) redemption use only and may not be combined with any other offer relating to the same reservation or accommodations.

The total amount of the prizes is 7.229€ which corresponds to the 8 tickets.

## **General Conditions for the Prizes:**
